# **EU Regulatory Affairs**

The pharmaceutical and medical device sectors are one of the most highly regulated in the world second only to the nuclear and aerospace industries. In order to keep abreast of current trends it is necessary for professionals working in those industries to be well acquainted with current and future trends and regulations.

Regulatory Affairs is an emerging profession increasingly gaining in importance.

### Aims of the Program

Participants will receive a thorough in depth training in all aspects of EU regulatory affairs covering both the pharmaceutical and medical device sectors. Due to the growing importance of regulatory affairs and the real deficit of higher education courses on this topic in the EU, this course is expected to fill an important gap in the pharmaceutical/ medical device sector in Europe.

Students will receive a certificate from the University for Continuing Education Krems after successfully completing the certificate program. The RAPS University Online Courses can be used as a preparation for the Regulatory Affairs Certificate (RAC) offered by the Regulatory Affairs Professionals Society (RAPS).

## Target Group

This Certificate Program targets regulatory affairs professionals with about 2–5 years experience in regulatory affairs.

### **Admission Requirements**

- > A university degree (at least bachelors) form an Austrian or other equivalent international University or
- > For candidates with no University degree: A/Levels or other high school leaving certificate and at least 2 years work experience in regulatory affairs or a closely related discipline or
- > For candidates with no University degree and no A/Level or other high school leaving certificate: at least 5 years work experience in regulatory affairs or a closely related discipline
- > Good English language skills
